I. LOCAL 817 COVERED POSITIONS:

ASSISTANT LOCATION MANAGER

Duties include following the direction of the Location Manager and overseeing all aspects of the location department's functions in serving the needs of the production.

LOCATION SCOUT

Duties include to search for locations for future use by productions and the securing of necessary permits and other required documentation for use of locations.

LOCATION COORDINATOR

Duties include working in the Production Office coordinating the daily work of, and providing clerical support for, the Locations Department.

The Location Coordinator acts as the information hub by receiving all the information from department members and disbursing accordingly.

LOCATION ASSISTANT

Duties include maintaining the negotiated condition and the use of location sites (set) and support spaces, in accordance with rental contracts or governmental permits. The Location Assistant serves as a liaison between the Location Department and worksite and communities (e.g. generating and distributing letters, set and directional signs, etc.).

II. NON-EXCLUSIVE JOB DUTIES:

Many specific functions are not exclusive and may be performed by any individual working in any covered job classification (e.g. answering phones, making copies, completing particular forms) and consistent with long-standing custom and practice are not exclusive to any particular job classification.

It is the intention of the parties to protect and preserve bargaining unit work for bargaining unit employees. The Employer will not give work to non-bargaining unit employees which is normally performed by bargaining unit employees where qualified bargaining unit employees are available.

OVERTIME

Weekly: Guaranteed 12-hour work day/60-hour work week

Time and one-half (1.5X) for all hours worked after 8 hours in a day or after 60 hours in a work week

Daily: Guaranteed 8-hour work day

Time and one half after 8 hours up to the 12th hour, Double time (2X) after the 12th hour

7TH CONSECUTIVE DAY OR HOLIDAY WORKED

2x for all hours worked

INDIVIDUAL ACCOUNT PLAN (IAP)

Currently 2.5% of the scale hourly rate. 3% as of October 2, 2022 3.5% as of October 1, 2023

PAID SICK LEAVE

1 hour of paid sick leave for every 30 hours worked up to 56 hours (48 hours if outside New York State). Sick leave may be used in minimum increments of four (4) hours upon verbal or written request of an employee.

CANCELLATION OF CALL

No later than 8pm on the evening before the day of the call.

REST PERIOD

8 hours between calls.

When the rest period is invaded, such employee shall receive double time (2X) at the applicable rate until such employee receives eight (8) hours of rest.

USE OF EMPLOYEES CAR (CHOICE IS AT THE EMPLOYER'S OPTION)

Currently

\$50.00 per day and production pays fuel.

\$70.00 per day inclusive of fuel

Effective October 1, 2023 increases of \$5 per day for ALM's and Scouts

Effective October 1, 2023 increases of \$10, if outside the 30-mile zone for ALM's and Scouts

HOLIDAYS

New Year's Day, Martin Luther King Jr. Day, Presidents' Day (third Monday in February), Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, the day after Thanksgiving and Christmas Day.

If holiday falls on a Saturday, the preceding Friday shall be considered the holiday. If the holiday falls on Sunday, the following Monday shall be considered the holiday. EXCEPT on distant locations, Saturday holidays will be recognized on Saturday.

If a daily employee works the business day before and the business day after a recognized holiday, the employee shall receive eight (8) hours of straight pay for that unworked holiday.

DISTANT LOCATIONS

Distant Locations are locations on which the employee is required to remain away and be lodged overnight.

HAZARDOUS WORK

May be refused without jeopardizing work opportunities.

If one chooses to work, you have the right to negotiate a fee in advance.

Contact the Union if you have safety concerns.

MEAL PERIODS

If a meal is not provided, you are entitled to reimbursement of \$9.50 for breakfast, 11.00 for lunch, \$14.50 for dinner, upon submission of receipts.

Effective October 1, 2023 reimbursements will be \$11 for breakfast, \$12 for lunch and \$16 for dinner, upon submission of receipts.

KIT RENTAL

ALM's and Scouts: \$20.00 (\$25.00 effective October 2, 2022) per day.

Location Assistants and Location Department Coordinators: \$10.00 per day.
